SECTION 1 — IDENTIFICATION

Product Use: Botanical aromatiser for olfactory or ambient purposes; may be combusted for aroma release.

Not for use as: Food, drink, medicinal, or cosmetic product.

Trade Description: Dried Cannabis sativa L. plant material (< 0.2 % THC) containing natural floral flavourings, aromas, and botanical compounds intrinsic to the hemp plant.

Age Restriction: Intended solely for adults 18 years and older. Minors are prohibited from purchase, possession, or use.

Customs Classification: CN Code 1211 90 86 — Aromatic or medicinal plants (hemp \leq 0.2 % THC). Legal Status: Fully compliant with Regulation (EU) 1307/2013 (industrial hemp \leq 0.2 % THC). Exempt from control under Maltese Dangerous Drugs Ordinance (Cap. 101). Lawful for sale and circulation within the EU except Ireland and Finland, where national restrictions apply. SECTION 4 — FIRST AID MEASURES

Inhalation: Move to fresh air. If symptoms persist, seek medical attention.

Biodegradable natural material; no known persistent hazards.

SECTION 13 — DISPOSAL CONSIDERATIONS

Dispose as plant bio-waste; do not release to waterways.

Not classified as dangerous goods (ADR, IMDG, IATA).
